

- **Error Updates**: The wording on the 404 and 500 error screens have been updated to enhance the user experience.

## **Bug Fix**

- This bug fix resolves an issue where unpaid pledges were not syncing through the
  automated data sync (ADS) to Donor CRM as expected. Now, pledges that were
  previously identified as pledges but have since been marked with a settled payment type
  will sync correctly through ADS.
- This update resolves an issue where the CSS code for dropdown menus (text message and org hub custom reports) was removed, causing the purple color and black font to no longer display correctly.
- This fix resolved the bug which prevented admin from downloading and opening large (over 20 MB) PDF files.



- Fixed an issue where TY Excel downloaded only one page of records. They are now
  prompted when clicking Download Excel (UTC) to confirm if they want only those
  checked or ALL RECORDS.
- Resolved an issue where the Thank You Letter Envelopes were not downloading in the proper format for printing.
- Resolved an issue that caused confusion User/Admins, where the email configuration details were shown when the Thank You Letter was a printed letter only.
